What About Emotional Distress After an Accident?

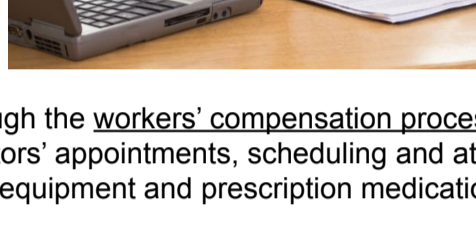


Emotional distress is a commonly sought noneconomic damage in car accident claims because the trauma of the experience can have severe and long-lasting effects on victims. It is not uncommon for victims to replay the crash in their minds long after the accident and find it difficult to shake these disturbing memories.

The [American Psychological Association \(APA\)](#) defines emotional distress as "some combination of anger or irritability, anxiety and depression, the three stress emotions." The APA classifies emotional distress as a symptom of acute stress, which the APA calls the most common form of stress.

What Does a Nurse Case Manager Do During a Workers' Compensation Case?

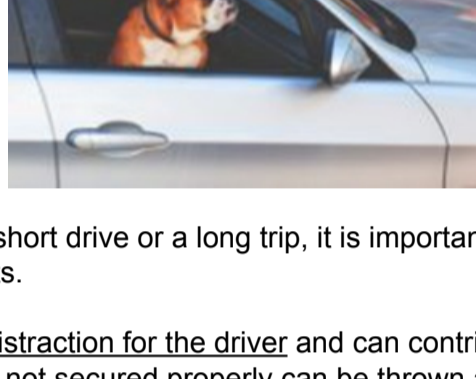


An injured worker going through the [workers' compensation process in South Carolina](#) will likely be tasked with attending doctors' appointments, scheduling and attending hospital visits, obtaining necessary medical equipment and prescription medications and participating in physical therapy.

In some cases, the [workers' compensation insurance](#) carrier may employ a nurse case manager to assist the injured worker with these tasks. It is important that the injured worker understands his or her rights during the workers' compensation process and the limits of the nurse case manager's role.

How to Keep Your Pets Properly Protected in the Car

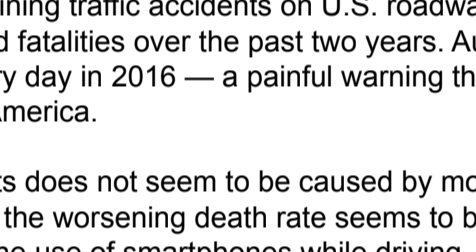


Whether you are going for a short drive or a long trip, it is important to properly secure your pets to prevent injuries in accidents.

Using a Smartphone While Driving Leads to an Increase of Distracted Driving Statistics

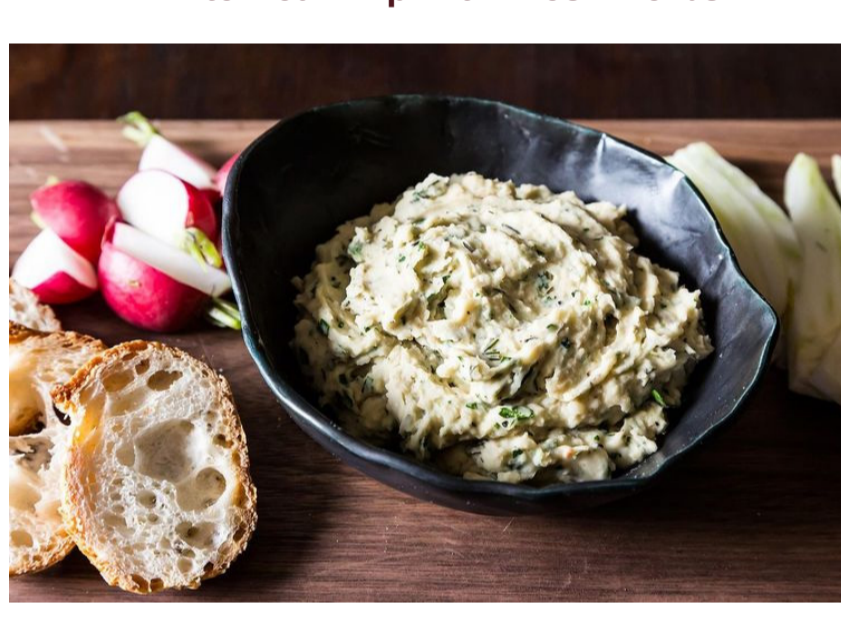


After several decades of declining traffic accidents on U.S. roadways, there was a sudden 14.4 percent surge in traffic-related fatalities over the past two years. Authorities report that there were 100 vehicle deaths every day in 2016 — a painful warning that something is very wrong on the streets and highways in America.

The increase in fatal accidents does not seem to be caused by more speeding or an increase in [drinking and driving](#). Instead, the worsening death rate seems to be a symptom of a growing societal problem: the rise in the use of smartphones while driving.

**Recipe of the Month
White Bean Dip with Fresh Herbs**



The perfect celebration of fresh herbs, this dip is wonderful with crostini, pita, radish slices, or even wrapped up in kale or romaine leaves. Serve with an extra drizzle of nice, fruity olive oil and bring it to your next holiday gathering!

Ingredients

- 2 cups cooked white beans
- 1 clove garlic, minced
- 4 tablespoons extra-virgin olive oil, divided into 1 tablespoon and 3 tablespoons
- 1 tablespoon chopped fresh rosemary
- 2 teaspoons fresh thyme
- 1 teaspoon sea salt (or to taste)
- Black pepper, to taste
- 2 tablespoons fresh lemon juice
- 3 tablespoons fresh parsley

Directions

1. In a medium-sized pan, heat the garlic in 1 tablespoon olive oil. Cook for two minutes, and then add the white beans, rosemary, and thyme. Sauté for another 4 to 5 minutes or until the garlic is soft and fragrant.
2. Transfer the beans to a food processor. Add the salt, pepper, lemon, and remaining olive oil. Process on high, stopping every now and then to scrape the bowl down, until mixture is totally creamy and smooth.
3. Pulse in the fresh parsley. Serve with an extra drizzle of olive oil.
