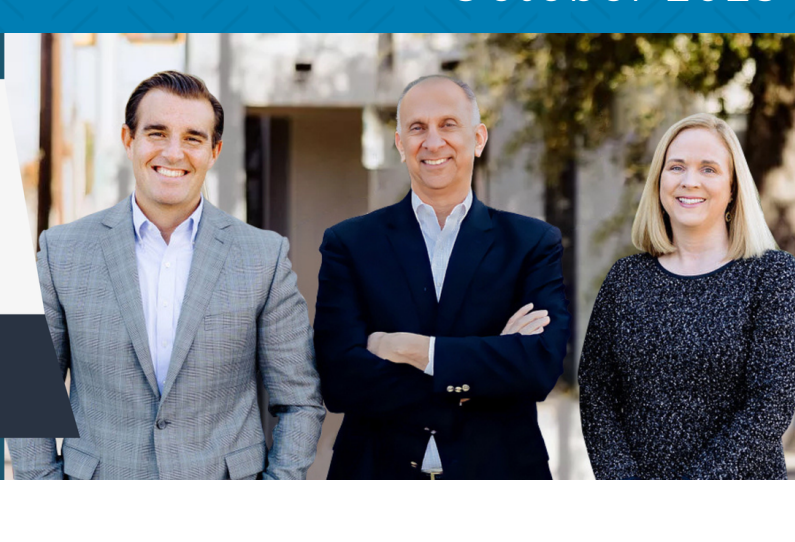

Brian's Guide to Forklift Safety



Quick Facts:

- Forklift injuries, on average, cause an injured worker to be away from work for 17 days - compared to 12 days for other workplace accidents.
- More than 7,700 workers experienced injuries from forklift accidents in one recent year.
- Manufacturing, transportation and warehousing, and wholesale trade are the three sectors that report the highest rate of forklift injury.
- The most common type of forklift accident is transportation incident with 52% of reported accidents.

Forklift Safety Tips:

Safe Speed
Operate the forklift at a speed that will allow it to stop safely.

Clear Backswing
Ensure that pedestrians or other obstacles are clear of the backswing.

Load Handling
When traveling with a load, make sure the load is tilted back and raised only as high as necessary to clear the ground.

Ventilate
Be aware of carbon monoxide poisoning when operating propane-powered forklifts indoors.

Secure Shutdown
Before getting off a forklift, lower the carriage, neutralize the controls, and set the brakes.

Three-Point Entry
Use three points of contact when getting on or off a forklift.

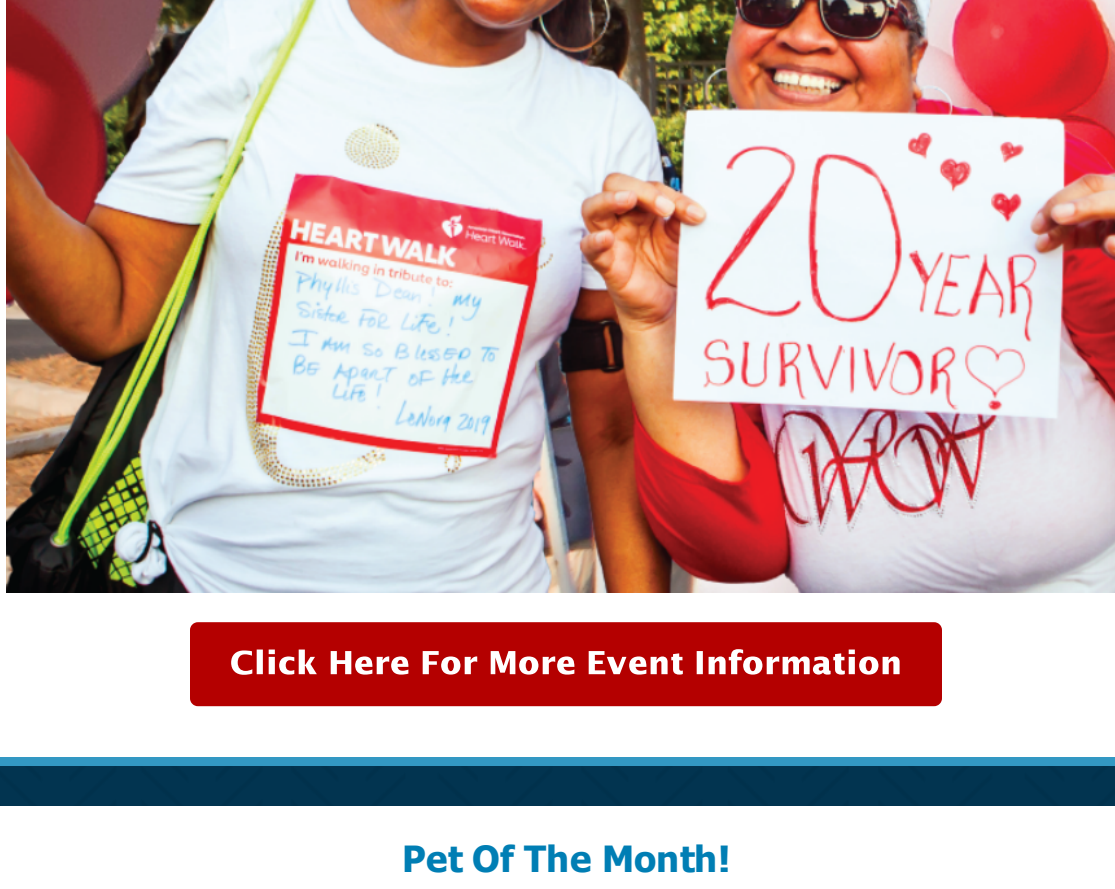

Recipe of the Month

Apple Cinnamon Bread

Anyone who tries this apple cinnamon bread will be thrilled. It has a hearty texture and sweet, home-baked flavor, but none of the fat and calories.



Ingredients

- 3 cups all-purpose flour
- 1-1/2 cup sugar
- 1 teaspoon baking powder
- 1 teaspoon salt
- 1 teaspoon baking soda
- 1 teaspoon ground cinnamon
- Two large eggs, room temperature
- 1/2 cup unsweetened applesauce
- 1/3 cup canola oil
- One teaspoon of vanilla extract
- 3 cups chopped peeled tart apples

Toppings

- 1/2 cup all-purpose flour
- 1/2 cup sugar
- Two tablespoons chopped walnuts
- 1/3 cup cold butter

Instructions:

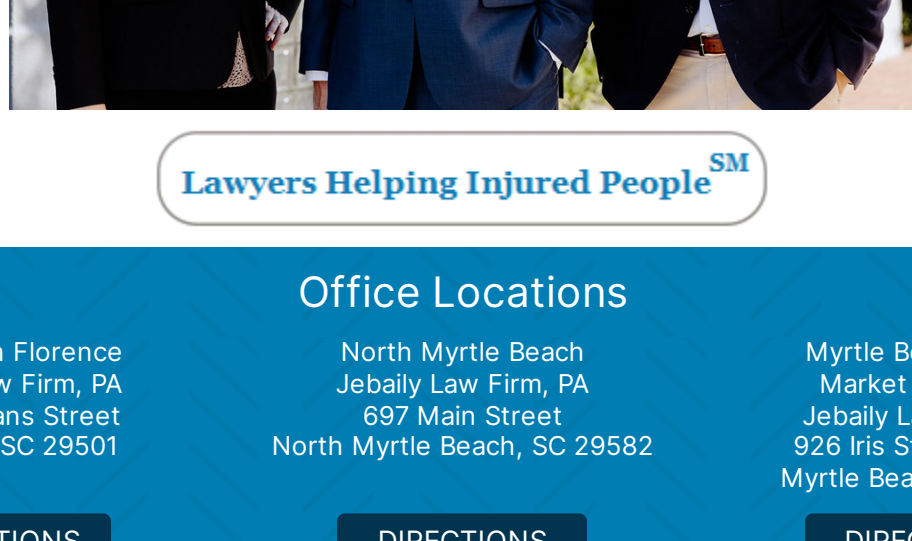
- Preheat oven to 350°. In a large bowl, combine the first six ingredients. In another bowl, whisk eggs, applesauce, oil, and vanilla. Stir into dry ingredients just until moistened. Fold in apples. Transfer to 2 greased 8x4-in loaf pans.
- For the topping, combine flour, sugar, and walnuts; cut into butter until crumbly. Sprinkle over batter.
- Bake until a toothpick inserted in the center comes out clean, 45-55 minutes. Cool for 10 minutes before removing from pans to wire racks.
